Landlord Tenant Rights. If an oral or written lease exists, or if a landlord has previously accepted payment as rent, a renter is granted rights under California landlord tenant law (CA Civil Code 1940-1954.05). These include the right to livable housing, a fair eviction process and more. California landlords also have certain rights, such as the right to collect rent in a timely manner and the ability to collect for property damages beyond regular "wear and tear".

Under state law, California landlords must disclose specific information to tenants (usually in the lease or rental agreement), such as whether the gas or electricity in the tenant's rental also serves other areas and information about toxic mold if the landlord knows that mold on the property exceeds exposure limits or poses a threat to the tenant's health.
