Passed by the 42nd Congress (1871-1873) as H.R. 320. Civil Rights Act of 1875: 18 Stat 335-337: Barred discrimination in public accommodations and on public conveyances on land and water.

Civil Rights Act of 1964 The most prominent civil rights legislation since Reconstruction is the Civil Rights Act of 1964. Congress, using its power to regulate interstate commerce, enacted the Civil Rights Act of 1964 under Title 42, Chapter 21 of the United States Code. Discrimination based on "race, color, religion, or national origin" in public establishments that have a connection to interstate commerce or are supported by the state is prohibited.
